For and on behalf of the Prodhan, Parulia Gram Panchayat under Khargram Development Block, Msd invites sealed percentage rate tenders for following work by two cover system up to **16.30 hours 20.02.2026**. Pre-qualification documents in a separate cover and Bid document with schedule rate in another cover are to be submitted by the **bonafide, reliable, reputed and resourceful contractors/ agencies** having experience in any nature of works from Khargram Development Block, Khargram Panchayat Samity, other Panchayat Samities and other Panchayats, Higher Panchayat Bodies, Municipalities and other Govt. offices including Block Offices with **at-least 40%** of the amount of work done earlier in **any nature of Civil work within last 6 (Six) financial years** as permissible credential, who satisfy the terms and conditions set out in pre-qualification document.

As the system of enlistment of contractors has been abolished vide Finance Deptt. Memo No. **2935-F(Y)** Date **8.12.2015**, the tenders of the Parulia Gram Panchayat are invited as open.

Intending bidders may **download** tender documents from e-procurement portal of our website <http://wbtenders.gov.in> from **14.02.2026 at 16.30 Hours to 20.02.2026 up to 16.30 Hours**. The pre-qualification and bid documents duly filled in all respect should be submitted through **on-line only** to the Prodhan, Parulia GP under Khargram Development Block, Msd up to **16.30 Hours (as per server clock) on 20.02.2026**. Prodhan, Parulia Gram Panchayat, does not take any responsibility for the delay caused due to non-availability of Internet connection or traffic jam etc.

Necessary **Earnest Money** and cost of tender paper will be deposited by the bidder electronically on line through his net banking enabled bank account maintained at any bank or offline-through any bank generating NEFT/RTGS chalan from the E-Tendering portal (<https://wbtender.gov.in>). Intending bidder will get the beneficiary details from E-Tender Portal with help of digital signature certificate and may transfer the EMD from their respective bank as per the beneficiary name and account no, amount, beneficiary bank name (ICICI) and IFSC code and E-procurement ref. no. Intending bidder who wants to transfer EMD through NEFT-RTGS must read the instruction of the challan generated from E-Procurement site. Bidder are also advised to submit EMD of their Bid at least (3) three working days before the bid submission closing date. As it requires time

for processing of payment of EMD. Bidder eligible for exemption of EMD as per Govt. rule may avail the same and necessary document regarding the exemption of EMD must be uploaded in the EMD folder.

The pre-qualification documents alone will be opened **on and from 23.02.2026 at 12.00 hours** by the Prodhan, Parulia GP under Khargram Development Block in presence of the bidders.

The date of opening of financial bid document of the technically qualified bidders will be intimated after **25.02.2026** or evaluation and selection of qualified bidders and the other bid documents will be unopened. No separate intimation will be given for this, unless the above date is changed.

No individual intimation will be given. Name of the qualified bidders will be displayed **in the office notice board**.

The Prodhan, Parulia GP under Khargram Development Block, Msd reserves the right to reject or cancel any or all pre-qualification documents and bid document without assigning any reason whatsoever

### **The Eligibility Criteria are given below: -**

1) The Credential should be submitted/uploaded at least 40% of the amount put to Tender supported by final payment Certificate and Completion Certificate within the last 6 years (**from 2019-20 to 2024-25**) in **any nature of Civil work** & completed the work successfully.

2) The Credential should be in the name & style of the intending tenderer only, and not in the name and / or style of any of the Partner(s).

Please note that, Final Payment Certificate and Completion Certificate along with Work Order will only be entertained as CREDENTIAL

3) Income Tax Return for the last 3 (Three) Assessment year with the technical bid.

4) Profession Tax with P-Tax receipt Challan for the current financial year, Trade Registration Certificate / License of Current Financial year from Local Bodies, GST Registration Certificate with up-to-date copy of Challan i.e. last Quarter Clearance (**upto December – 2025**) as the case may be.

5) A prospective bidder shall be allowed to participate in the work either in the capacity of individual or as a partner of a firm.

6) Each Bidder shall submit/upload Bid against any **Five (05)** Serials in each NIT. A Bidder who submits/uploads Bid more than the serials mentioned in the NIT will cause the proposals with the Bidder's participation to be disqualified.

7) Bidder must submit a Declaration shown no relation with PIA body and Panchayat Staff with the contractor copy furnished in Non-Judicial of Ten rupees stamp paper of appropriate value duly notarized .

8) The partnership firm shall upload the registered partnership deed and the company must furnish the Article of Association and Memorandum.

9) In case of Engineering –Co- operative and Labour Co- Operative society Ltd. and Partnership Company, Partnership deed & audit papers for the financial year 2024-25 are to be submitted. No exemption will be allowed regarding deposit of Earnest money.

10) Receipt copy of deposit (Cost of Tender Paper & Earnest money) Challan should be uploaded with the tender documents. Original challan should be submitted during the financial opening of the tender.

11) Copies of original documents defining the constitution or legal status, place of registration, and principal place of business; written power of attorney of the signatory of the Bid to commit the Bidder. .

12) All the documents in proof of their eligibility IN ORIGINAL need to be produced as and when asked and required. \* The scope of Sub-Contracting is not allowed strictly by anyway.

13) Information regarding any litigation or arbitration during the last five years in which the Bidder is involved, the parties concerned the disputed amount, and the matter.

14) To qualify for a work of contracts made up of this and other contracts for which bids are invited in the Notice Inviting Tender, the bidder must demonstrate having experience and resources sufficient to meet the aggregate of the qualifying criteria for the individual contracts.

15) Even though the bidders meet the above qualifying criteria, they are subject to be disqualified and legal action may be taken if they have:

(i) Made misleading or false representations in the forms, statements, affidavits and attachments submitted in proof of the qualification requirements; and / or record of submission of any false / fake document(s).


(ii) Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.

(iii) Participated in the previous bidding for the same work and had quoted unreasonably high or low bid prices and could not furnish rational justification for it to the Employer.

- 16) Before the deadline for submission of bids, the Employer may modify the bidding documents by issuing addenda.
- 17) Acceptance of lowest tender is not obligatory & the undersigned reserves the right to accept any tender or to reject any or all tenders without assigning any reason and to split up tendered work's to more than one contractor in the interest of speedy execution of the scheme.
- 18) The undersigned reserves the right to alter the terms and condition of this notice at any time in the interest of public service.
- 19) Any above rate of the scheduled rate of work will not be ordinarily entertained.
- 20) Work order amount may differ from tender amount as per allotment of fund.
- 21) Contractors must submit PAN Card with the technical bid.
- 22) If any Contractor fails to fulfill any of the above criteria, his/her Tender will be cancelled without giving any previous information.
- 23) All rules & regulations in vogue regarding call of tender/ quotation governed by the Finance Department, Govt. of W.B. and the West Bengal Zilla Parishad & Panchayat Samity Financial Rules shall remain applicable for this tender.

The amount of earnest money is 2% of the estimated cost of construction for each work. All duties, taxes, royalties, cess, [including 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Act, 1996], toll, taxes and other levies payable by the Contractor under the Contract to the State / Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. 1% Cess under W.B. Building and other Construction Workers (Regulation of Employments & Condition of Service) Welfare Cess Act, 1996 will be deducted from the running bills if applicable.
